RULES AND REGULATIONS

- 1) **ELIGIBILITY** – The PIAP Ten-Pin Fellowship Bowling Tournament is open to the representative, members and employees of PIAP member companies in good standing.
- 2) **REGISTRATION** – Only participants who have sent in their signed registration and paid their tournament fee on or before **May 11, 2018** (Friday) will be allowed to sign on **May 20, 2018** (Sunday) at 8:00 A.M.
- 3) **TARDINESS & ABSENT BOWLERS** – If a bowler arrives late before the first player (on their assigned lanes) plays his/her 6th frame, he/she will be given a blind score of 10 pins per frame he/she missed. If he/she arrives after, a blind score of 100 pins will automatically be given him/her for the first game. There will be no refund of tournament fees for absent bowlers.
- 4) **BOWLING ETIQUETTE**
 - a) Play would be one frame at a time.
 - b) A bowler must not step up on the lane approach when another bowler is in his/her left or right side is positioned to roll the ball.
 - c) The bowler always allows the bowler on his/her right to play first.
 - d) Avoid heckling, noise and all forms of distractions that may affect the bowler ready to roll his ball.
 - e) Absolutely no food, drinks, eating or smoking at the playing area.
 - f) Only players with assigned lanes may stay in their lanes playing area.
 - g) Participants must wear bowling shoes to comply with the tournament venue requirements.
- 5) **TIEBREAKER** – In case of tied score, bowlers will play-off for two frames to break the tie.
- 6) **SCORING** – Participants will submit their game score or pinfalls in a signed score sheet after every game to the committee. Late submission may incur penalties.
